

**SUMMARY OF THE CHARTER
OF THE INTERNATIONAL COALITION
FOR PEACE IN THE WORLD
(ICFPIW)**

PREAMBLE

The United Nations Organisation (UN) was established after the Second World War in 1945. The Charter of the UN was written by the victorious states, mainly the USA. The Security Council of the UN is designed to prevent any resolution against 5 states (the USA, Russia, China, France and the UK). This veto system was not able to prevent genocidal actions, war crimes and crimes against humanity since the establishment of the UN. Furthermore, the UNSC was not able to prevent or stop the conflicts at which one of the states with veto power is a party.

The illegal and illegitimate "combined military, intelligence and police operation" that the United States of America launched against Venezuela on January 3, 2026, has caused deep concern and anxiety in the international community. This was a blatant and clear violation of many instruments of International Law. The real aim of the attack is to acquire Venezuelan petrol and mines. This has been declared to the international community by US President Donald John Trump at press conferences and in his several statements.

Individuals within the international community - qualified in legal, political, academic, and even religious fields - who cannot remain silent in the face of such a "border-lessness" in the 21st century, have reacted reflexively and undertaken certain initiatives as a result of their interactive efforts since January 3, 2026. Representatives from some other international actors (such as states, international organisations, NGOs or Universities) have also contributed to the process.

The International Coalition for Peace in the World (ICFPIW) was established on January 3, 2026. These efforts are coordinated by the **Headquarters of the ICFPIW**. The ICFPIW is an **international actor** with respect to the Science of International Relations and has the qualification to benefit from the **International Law**. The **ICFPIW** is an **International Organisation** in compliance with the basic principles of the **Science of International Relations**.

H.E. Ambassador Abdullah Metin Durmuş, has introduced the **Modular System Theory on International Relations (MSTonIR) in 2006**. Three assumptions of the theory are laid down in the study which defines the modular character of international actors as well as the international system itself:

- 1. International system functions as a module, consisting of other modules, which are called actors of international relations.*
- 2. The actors of international relations do also function as a module. An entity which cannot function as a module cannot be regarded as an actor of international relations.*
- 3. The actor which fails to function as a module for a specific period of time may be dissolved or divided and embedded in another international actor in such a way that the global balance of power will not be adversely affected.*

The **ICFPIW** also has a modular character. Consequently;
First, the ICFPIW has already fit in the International System due to the urgent necessity for peace in the World.

Second, the General Assembly of the **ICFPIW** consists of individual and institutional actors (modules). Total number of these actors may change depending on the “danger” in question.

Third, when the ICFPIW foresees or observes that international peace and security is in danger, the organisation intervenes to preserve the global balance of power.

CHAPTER 1: ORGANIZATIONAL STRUCTURE

Secretary General: H. E. Adam Jesus MUSTAPHA.

Commander in Charge for Coordination: General Martin HALTMANN
(Graduation Year: 1993).

Permanent Representative of the ICFPIW to the United Nations: H.E. Ambassador Abdullah Metin DURMUŞ.

International Community's Court (ICsC): It is composed of 13 (thirteen) judges from all continents of the World and is located in the European Union,

Prosecutor of the ICsC: *** (International Court Registry Number: LL - 1284).

The General Assembly: Consists of individuals, and representatives of states or other organisations.

The Secretary General, Commander in Charge, Permanent Representative, Prosecutor and judges of the ICsC have diplomatic immunities and privileges in accordance with the Vienna Convention on Diplomatic Relations of 1961.

CHAPTER 2: BASIC PRINCIPLES

The ICFPIW acts when it foresees or observes that international peace and security is in danger.

The ICFPIW functions in accordance with the articles 52 and 54 of the UN Charter. However, ICFPIW may resort to other means, which are not vested in the UN Charter, to deal with the “danger”. The ICFPIW reserves the right to communicate with any organ of the United Nations and permanent representatives of the UN member states.

There is **NO VETO RIGHT** for anybody or for any institution at the General Assembly.

ICFPIW can hire as many staff as it needs, such as experts, accountants, secretaries, guards, and drivers, whenever it needs them.

ICFPIW can buy or rent offices or residences for the Secretary General, Commander in Charge, Permanent Representative, the Prosecutor and judges of the ICsC. **ICFPIW** has started the process to rent an office and / or a residence for the Permanent Representative in accordance with its Charter. The address of the premises will be kept secret due to security reasons so long as it is deemed necessary.

CHAPTER 3: BUDGETARY PROVISIONS

Members of the General Assembly of the ICFPIW or other non-member individuals or institutions may financially contribute monthly to the budget of the ICFPIW. Financial contribution is voluntary and the amount depends on the member or donor. **The ICFPIW will appreciate every drop of water for the sacred tree of Peace in the World.** If any donor does not want their name to appear on the balance sheet, please inform the Permanent Representative directly.

ICFPIW may collect income through various financial methods.

Budget will be spent for buying or renting the premises of the **ICFPIW**, such as office or residence, daily cost such as electricity, water, heating, telephone, internet etc.

Monthly allowances will be paid for the Secretary General, Commander in Charge, Permanent Representative, Prosecutor and judges of the ICsC if and when needed.

Bank account for the Budget of the **ICFPIW** opened by the Permanent Representative.

Budget spending will be transparent. Balance sheet of the previous year will be forwarded to the members each year in February.

BOOK 1: While chatting with locals in the courtyard of the mosque in Sultan Hamud, Kenya, I was thinking about how the Ottoman Empire had once been engaged in a power struggle with imperialist states in East Africa. Islam had arrived in this region centuries earlier. Back then, the people, not yet exposed to the intrigues of the modern world, had readily embraced this religion of love that fostered inner peace.

As a result of developments in the field of Social Sciences in the 20th and 21st centuries, "International Relations" has proven its worth as a discipline based on various theories and supported by the comparison of quantitative data.

While walking in the national park in Nairobi, the capital of Kenya, he was struck by the dignity of the animals they encountered. They didn't bow to anyone. They were able to feed themselves. They had created a habitat. In fact, humans were engaged in the same effort. Their aim was to be part of the society in which they lived and to meet their basic needs.

States are also organized according to the principle of protecting the rights and interests of their citizens united under a flag. States that do not protect their flag deserve to disintegrate. In this respect, states exhibit modular characteristics within the international community in which they live (For a comprehensive examination of this topic, please see the author's article titled "**Modular System Theory on International Relations**").

During sea voyages, you sometimes encounter rocky outcrops. These seemingly calm rocks can sometimes be your most formidable enemy. In diplomacy, too, you face a new challenge every day. For example, you may observe that one of the major powers is planning an air strike against a neighbouring country, assassinating its leadership (their project in 2006). You foresee that if this plan is carried out, it will be detrimental to your country in the long run. Even if you share this prediction with your colleagues, they may believe that it is impossible to confront a major power. However, in diplomacy, solutions are endless. **Sometimes a diplomat, alone, can change the course of events.**

It was a spring day in 2006 in Ankara. The time was 1:30 AM. He was spending the night at home, working on the calculations that formed the core of his article. At the same time, he was considering ways to prevent the threat facing the neighbouring country from spreading to his own. After all, there was the possibility of chemical or nuclear weapons being used against the neighbouring country. There wasn't much time to think. He decided to do what an Ottoman ambassador would do if faced with such a situation.

As required by academic discipline, while gathering information and collecting documents, I have carried out theoretical and empirical analyses of the developments. **The outcome is this book**.


On the other hand, we have to acknowledge the "precious contribution" (!?) of the Government of Israel under Benjamin Netanyahu for the initiation and formation of the International Coalition since October 7, 2023. Some politicians and diplomats assume that they can easily defeat their opponents if they possess a large number of aircraft, armoured vehicles, or weapons. However, throughout history, and even in modern times, we have observed pilots or soldiers abandoning their positions even when sufficient equipment and ammunition remain.

On the other hand, if soldiers are defending their homeland, they will resist with bayonets, or even with their bare hands, when their ammunition runs out, as was the case with the **Ottoman soldiers under Mustafa Kemal Atatürk's command** at Gallipoli in 1915.



(And the Nobel Peace Prize goes to Mr. Trump. January 15, 2026)

Mr. Donald J. Trump several times stated his desire to **GET** (not being awarded) the **Nobel Peace Prize**. He achieved this goal on January 15, 2026, during his meeting with Venezuelan “poor and desperate” citizen **María Corina Machado**, when she presented it to him during their meeting. He was able to get the Prize, **with little help** of the US State Department, the Pentagon and several American intelligence staff. The Nobel Authority, most probably, will **reconsider their criteria** to award this important prize and **postpone** delivering Peace Prizes until further notice.

Here is a list of **some of Mr. Trump’s achievements** by means of which he **deserved “a” Prize**:

1) Trade War:

Trade War is also a war, which is not fought with weapons. He started a **Global Trade War** by means of "playing" with the rates of US customs tariffs in 2025. It is such a chaos that we will be able to calculate the global (including to the US

citizens) financial, economic, industrial, technologic and labour cost of this policy only after 3 years.

On January 17, 2026, United States President Donald **Trump** pledged a series of **increasing tariffs** on several European allies for their opposition to US control of **Greenland**. Trump said **10 percent tariffs** would come into effect on February 1 for **Denmark, Finland, France, Germany, Norway, Sweden, the Netherlands and the United Kingdom**. He added that these **tariffs would rise to 25 percent on June 1** and continue until an agreement is reached for the US to buy Greenland. Trump indicated in that the tariffs were being imposed in retaliation for trips the countries' representatives took to Greenland "for purposes unknown". He accused all eight of playing a "very dangerous game" in opposing US control over the territory.

European leaders rejected Trump's announcement, with **French President Emmanuel Macron** saying that "no intimidation or threat will influence us—neither in Ukraine, nor in Greenland, nor anywhere else in the world when we are confronted with such situations". "Tariff threats are unacceptable and have no place in this context. Europeans will respond in a united and coordinated manner should they be confirmed. We will ensure that European sovereignty is upheld,"

UK Prime Minister Keir Starmer was unusually blunt in condemning Trump's threat, saying that his country would raise the issue directly with Washington. "Applying tariffs on allies for pursuing the collective security of NATO allies is completely wrong," he said.

European Union foreign policy chief Kaja Kallas said tariffs would undermine prosperity on both sides of the Atlantic, making both Europe and the US poorer. "China and Russia must be having a field day. They are the ones who benefit from divisions among allies," she said.

2) USA Supports Wars by the State of Israel (the Government of Israel is a Terrorist Organization since October 2023):

a) Government of the State of Israel, under leadership of Benjamin Netanyahu, has been carrying out an "combined operation" in Palestine (**Gaza and West Bank**) since October 8, 2023. INTRODUCTION AND CONCLUSION

As a result of developments in the field of Social Sciences in the 20th and 21st centuries, "International Relations" has proven its worth as a discipline based on various theories and supported by the comparison of quantitative data.

The UN Security Council is **paralyzed** in two cases: **First**, if a member state of the UN Security Council (the Russian Federation vs Ukraine case) is a party to the conflict. **Second**, the aggressor state is supported by a state with veto power

in the UN Security Council. The USA remains indifferent to Israel's occupation policy and massacres in Palestine (both Gaza and the West Bank) for years, and even providing financial, political, military and intelligence support during Israel's genocidal activities.

The fact that the United Nations Organization, with its current structure and decision-making system, cannot prevent aggressor states from ignoring International Law (the UN Charter, relevant Human Rights Law instruments etc) shows that the UN system needs urgent reform.

C) No official in the United States, or in Israel, including the President of the USA, or any US official or judicial institution, has the authority to accuse any Head of State or Government, or any Minister of Government, of crimes such as "international terrorist" or "international drug trafficker," to issue arrest warrants, to conduct operations within or outside the United States or Israel, to detain, abduct, hold hostage, prosecute or execute them.

The allegations must first be investigated by an international, impartial commission established by the competent organs of the United Nations. The suspects must then be tried in a legitimate court directed by the UN, based on the outcome of the commission's report.

With respect to the Sciences of "**International Relations**", "**International Law**" and "**Laws of War**" following conclusions may be drawn: Air strikes at a foreign country, kidnapping people, killing and wounding people, causing fear and panic within a community is simply called as **terrorism**.

Consequently, **Trump Administration and Government of Israel can be described as terrorist organisations**. Some members of the **Trump Administration** and the **Government of Israel** and the **generals, officers, soldiers, civil staff, and intelligence members of the USA, Israel and / or any country**, who executed the orders of these terrorist organisations **can be called as terrorists**.



Following suspects, which are members of the Trump Administration, are just PUPPETS OF THE STATE OF ISRAEL. However, this fact does not prevent International Courts to hold them responsible for their war crimes and crimes against humanity.

G. VICTIMS: SINCE OCTOBER 7, 2023;

More than 70.000 (**Seventy thousand**) Palestinians were killed in Gaza and the West Bank. More than 1300 (**One thousand three hundred**) civil Iranians (including Iranian civil and religious leadership, more than **160 school children**) were killed and more than 700 Iranians wounded during the US and Israeli attacks. In Lebanon, more than 1.000 (**One thousand**) civilians were killed by Israeli attacks. More than 100 Iranian sailors were killed by US strikes with no prior warning or request of surrender of the ship. **These actions are against the Laws of War.** The indictment for the **Biden Administration** is at the ICC.

H. SUMMARY OF THE INDICTMENT

The USA and Israel have started combat and intelligence operations against Iran on February 28, 2026. The result is Middle East War.

With Respect to the Sciences of "International Relations", "International Law" and "Laws of War", following conclusions may be drawn: Air strikes at a foreign country, killing people, causing fear and panic within a community is simply called as TERRORISM.

This is a blatant and clear violation of many instruments of the International Law.

On the basis of evidence collected and examined by Our Office, we have reasonable grounds to believe that the suspects with numbers 1, 2, 3, 4, 5, 6 and 7 committed crimes, among other instruments of the International Law, against the Charter of the United Nations of 1945, against the Universal Declaration of Human Rights of 1948 and against the North Atlantic Treaty of 1949. This is also against humanity, contrary to relevant articles of the Rome Statute;

- Wilful killing contrary to article 8(2)(a)(i), or Murder as a war crime contrary to article 8(2)(c)(i);
- Murder as a crime against humanity, contrary to article 7(1)(a), and as a war crime, contrary to article 8(2)(c)(i);
- Intentionally directing attacks against a civilian population as a war crime contrary to articles 8(2)(b)(i), or 8(2)(e)(i);
- Taking hostages as a war crime, contrary to article 8(2)(c)(iii);
- Torture as a crime against humanity, contrary to article 7(1)(f), and also as a war crime, contrary to article 8(2)(c)(i), in the context of captivity;
- Other inhumane acts as a crime against humanity, contrary to article 7(1)(k), in the context of captivity;
- Cruel treatment as a war crime contrary to article 8(2)(c)(i), in the context of captivity; and
- Outrages upon personal dignity as a war crime, contrary to article 8(2)(c)(ii), in the context of captivity.
- Persecution as a crime against humanity contrary to article 7(1)(h);
- Other inhumane acts as crimes against humanity contrary to article 7(1)(k).

The Administration of the USA or Israel does not have the international legal authority to ask another state to stop its peaceful nuclear energy programme. The Administration of the USA or Israel does not have the international legal authority

to label any leader of another state or any group of people as terrorists. Such a decision to decide which states or groups are breaching International Law lies with the United Nations Security Council.

Neither the Administration of the USA nor Israel does have the international legal authority to execute military operations outside US territory, unless there is an armed attack against US territory. (Article 51 of the UN Charter: Nothing in the present Charter shall impair the inherent right of individual or collective self-defence if an armed attack occurs against a Member of the United Nations, until the Security Council has taken the measures necessary to maintain international peace and security.)

The Administration of the USA does not have the international legal authority to execute “law enforcement operation” outside US territory. Violating international law undermines legal and moral legitimacy both with regard to the International Community and US domestic politics and jurisdiction. In fact, there is no democracy or rule of law in Israel.

Consequently, Trump Administration and the Government of Israel can be described as a terrorist organisation. The abovementioned members of the Trump Administration and the US Army generals, officers, soldiers and civil staff members, who executed the orders of this terrorist organisation can be called as terrorists.

Our Office submits that the war crimes alleged in this warrant were committed in the context of an armed attack of the US and Israeli Armed Forces against Iran on February 28, 2026. We submit that the crimes against humanity charged were part of a widespread and systematic attack against the civilian population of Iran. Some of these crimes, in our assessment, may continue to this day by means of military and civilian US and Israeli citizens in Iran.

It is the view of our Office that these suspects planned and instigated the commission of crimes and have through their own actions, acknowledged their responsibility for those crimes. We submit that these crimes could not have been committed without their actions. They are charged both as co-perpetrators and as superiors pursuant to Articles 25 and 28 of the Rome Statute.

Our Office also submits there are reasonable grounds to believe that some hostages taken from Iran have been kept in inhumane conditions, and that some have been subject to violence, including rape, while being held in captivity. We have reached that conclusion based on medical records, contemporaneous video and documentary evidence, and interviews with victims and survivors.

We wish to express our gratitude to the survivors, and the families of victims of the February 28, 2026 attack, for their courage in coming forward to provide their accounts to our Office. We remain focused on further deepening our investigations of all crimes committed as part of these attacks and will continue to work with all partners to ensure that justice is delivered.

Today we underline that international law and the laws of armed conflict apply to all. No foot soldier, no commander, no civilian leader – no one – can act with impunity. Nothing can justify wilfully depriving human beings, including so many women and children, the basic necessities required for life. Nothing can justify the taking of hostages or the targeting of civilians.

The independent judges of the International Community’s Court are permitted to conduct their work with full independence and impartiality. We insist that all attempts to impede, intimidate or improperly influence the officials of this Court must be avoided. Our Office will not hesitate to act if such conduct occurs.

CRUCIAL REMARKS:

Our Office has jurisdiction over crimes committed by nationals of Member States of the United Nations and by the nationals of observer and non-States.

An international independent commission composed of independent academicians, experts and independent lawyers will be established in order to define the states which support the USA politically, financially and militarily.

Cultural and Sports Boycott:

Each member state of the United Nations will stop all cultural, sports and social interaction with the USA and Israel immediately. **The World Football Cup Competition in the USA must be cancelled.** The teams of football, basketball etc. which are registered in the USA and in Israel will be banned from all international events. The right of participation of the US or Israeli national football team to this Competition will be revoked. Because, the territory of the USA is now a front line of the 3rd World War. US military and civilian assets and some US citizens are possible targets worldwide. No military or police force can

protect the highly valued international football players and thousands of spectators in the USA.

The US and Israeli national teams and club teams will be declared defeated at international events. The USA and Israel will be banned from all summer and winter Olympics and other international events. The athletes who have a US and Israeli passport will not be allowed to participate in any international sports event even under other state's flag or independently. The artists, directors, musicians, who carry a US and Israeli passport will be banned from all international shows, exhibitions etc. All US and Israeli cinema, theatre, opera and ballet shows will be cancelled.

Preaching Method: In mass. Reading and / or explaining the meanings of the Teachings at home, office, school, university, holy buildings or at parks.

CHAPTER 1: WHO IS HUMAN?

Revised Teachings for Chapter 1:

- 1) Human is the one who does not kill other human beings, except in legitimate self-defence situations.
- 2) Human is the one who does not benefit or be proud of killing people, even his “enemies”. Benjamin Netanyahu’s exploiting religious feelings of Jews in order to justify his genocide in Gaza and executions in Iran, are disgusting. SUBJECT: DO NOT ATTACK NUCLEAR FACILITIES ANYWHERE!

The Permanent Representation of the International Coalition to the United Nations presents its compliments to the Permanent Representations of the relevant member states and has the honour to bring your attention the following:

A military attack by one state on another **state's nuclear power facilities is a serious crime under International Law**. Such attacks are prohibited, along with other instruments of International Law, under Article 56 of the First Additional Protocol to the **Geneva Conventions and the Hague Statute**.

Violation of International Law:

- The First Additional Protocol to the Geneva Conventions provides for the protection of nuclear power facilities from military attacks.
- According to Article 56, attacks on nuclear power facilities are prohibited if they pose a serious risk to the lives of civilians.
- The Hague Statute prohibits damage to and destruction of enemy property.

Consequences of the Crime:

- Such attacks may be considered war crimes under international law.

- The attacking state incurs international responsibility and may be required to pay compensation.

- The International Court of Justice may assess such attacks and hold the relevant states accountable.

Important Note:

- Attacks on nuclear power plants can cause serious harm to human rights and the environment. The damage not only affects the target state but also neighbouring states.

- The international community must continue to work to prevent such attacks and ensure the safety of nuclear power plants.

- The Geneva Convention and the Hague Statute do not provide for a statute of time limitations for war crimes.

- According to the ICC's founding statute, there is no statute of time limitations for crimes such as war crimes, crimes against humanity, and genocide.

Leaders of states that violate the First Additional Protocol to the Geneva Convention and the Hague Statute may be tried before the International Court of Justice (ICJ) or the International Criminal Court (ICC).

- International Court of Justice (ICJ): It is the principal judicial organ of the United Nations. Its task is to resolve disputes between states and to provide advisory opinions on questions of international law.

- International Criminal Court (ICC): It was established to prosecute individuals who commit international crimes such as war crimes, crimes against humanity, and genocide.

On June 22, 2025, US President Donald Trump announced that the US Air and Naval Forces had launched attacks on Iran's Fordo Nuclear Facility, Natanz Nuclear Facility, and various nuclear facilities in Isfahan. The US codenamed the attack Operation Midnight Hammer.

We expect civilian and military personnel who have committed war crimes to be tried promptly by competent courts.

The International Coalition is an International Organisation in compliance with the basic principles of the Science of International Relations. The

International Coalition functions in accordance with the article 52 of the UN Charter.

We would like to remind that under the auspices of the International Coalition there is an *ad hoc* “International Community’s Court” composed of 13 (thirteen) judges from all continents of the World, which is located in the European Union, and a Prosecutor (International Court Registry Number: LL - 1284).
